THE GIG FUND



Our fund is independent and student-run with over \$20,000 in AUM

- ✓ Comprised of 20 analysts, of varying experience levels, whom are selected by the committee through an application process.
 - Less experienced analysts are generally paired with more experienced analysts.
- ✓ The purpose of the Fund is to be educational, providing students with practical skills such as building financial models and pitch decks.
 - Analysts attend seminars and workshops to improve and enhance their pitches.
 - Our PSC+ program also offers students the opportunity to learn skills directly applicable to a career in financial services.
- ✓ While, in the past, the Fund has actively managed approximately \$20,000 (achieving a 30.4% return during the 2020-2021 academic year), the Fund's committee has altered the structure of the Fund.
 - With our new non-profit status, the Fund now features an investor relations team to raise money for an annual closed-end fund. Therefore, in place of our actively-managed fund, the annual closed-end fund which terminates after three to five years will be comprised of the stocks from the most promising pitches from across the year.

INVESTMENT BANKING CERTIFICATE



In line with its educational goals, the Global Investment Group offers the PSC+ in Investment Banking, which was developed in collaboration with the University's Careers Centre. The course is available to all members of the organization and aims to provide them with the necessary background to pursue a career in financial services. Additionally, students who complete the course requirements receive an official certification from the University that is displayed on their diploma.

Our PSC+ sessions include topics such as (but are not limited to) the following:






